PRIVACY POLICY

Kakona is committed to protecting your privacy and we strive to be completely transparent with how we collect and use information we gather about you on this site. Your privacy is important to us and we respect your preferences. This Privacy Policy (“Privacy Policy”) governs our data collection, processing and usage practices. It also describes your choices regarding use, access, and correction of your personal information.

The Privacy Policy explains how SALDCO, Ltd., (“Kakona”) uses personal information (“Personal Information”) and it applies to all users (“users”) who access, view, visit, download, or otherwise interact with <https://www.kakona.com> (the “Site”). By visiting the Site, you are accepting the practices described in this Privacy Policy. If you do not agree with the data practices described in this Privacy Policy, you should not access, view, visit, download, or otherwise interact with the Site. Information We Collect

Personal Information. “Personal Information” is any information that you voluntarily submit to us, identifies you personally, and allows us to contact you. Personal Information can include, but is not limited to, contact information such as name, email address, company name, address, phone number and other information about yourself or your business. Personal Information can also include information about any transactions, both free and paid, that you enter into on the Site, and information about you that is available on the internet, such as from Facebook, LinkedIn, Twitter and Google, or publicly available information that we acquire from service providers. Personal Information also includes Navigational Information and log files provided by our third-party tracking-utility partners. Navigational information and log files refer to information about your computer and your visits to this website such as your IP address,

geographical location, browser type, referral source, length of visit and pages viewed. This information helps Kakona analyze and understand how the site works for users.

Mobile Location Information. If you have permitted your mobile or other location-aware device to transmit location data, Kakona collects Mobile Location.

Information About Children. The Site is not intended for or targeted at children under 16, and we do not knowingly or intentionally collect information about children under 16. Posted Information. If you chose to post a comment on Kakona's blog, Kakona may collect information regarding your name and the content of your post. It is important to note that any content you post on the blog is publicly displayed and will be seen by other users of the Site.

How We Collect Personal Information

Kakona gathers Personal Information if and when you are prompted to provide Personal Information (including Contact Information) when you use or interact with the Site or when you contact us. For example, Kakona uses cookies and related technologies to collect information about your computer and your interaction with the Site. We may also gather your Personal Information if and when you contact Kakona via telephone, email, or other methods of communication.

How We Use Information We Collect

Kakona uses the information we collect only in compliance with this Privacy Policy.

We Never Sell Personal Information

We will never sell your Personal Information to any third party. Kakona may use Personal Information to enhance your user experience, to help us better understand you, to help us customize offers, blog topics, or posts that may be of interest to you, and to help us otherwise enhance the Site.

Kakona uses Personal Information to:

- Identify and authenticate users;
- Facilitate transactions;
- Operate and improve the Site;
- Connect with you on social media (such as Facebook, LinkedIn, or Twitter);
- Contact you by phone or email;

- Personalize and continually improve users' Kakona experience;
- Provide you with suggested information based on variables such as stated preferences, interests, business activities, and/or location;
- Send you technical notices, updates, alerts and support, and administrative messages service bulletins, or marketing;
- Evaluate additional services, items, or offerings that may be of interest to users;
- Track transactions and perform other analytics;
- Communicate and provide additional information that may be of interest to you about Kakona partners or third parties; and
- Manage Kakona everyday business needs such as Site administration, communication management, analytics, fraud prevention, enforcement of our corporate reporting obligations, Terms of Use or to comply with the law.

When and Why Kakona Discloses Personal Information

Kakona will not disclose your Personal Information to third parties without your explicit consent, except as specified in this Privacy Policy. Kakona will disclose your Personal Information when:

- Working with companies and service providers (i.e. HubSpot or other companies that process billing, website hosting, or analytics performance) in furtherance of the purposes described in "How We Use Information We Collect" above.
- Kakona employs other companies to perform tasks on Kakona's behalf and therefore Kakona must share your Personal Information with these companies to provide services to you. Examples include but are not limited to processing payments, analyzing data, providing marketing assistance, and providing customer service. Kakona may partner with third-party services for fraud prevention and/or identity verification.
- Enforcing Kakona's rights or protect Kakona property and intellectual property;
- Protecting the rights, property or safety of others, investigate fraud, respond to a government request.
- Kakona believes in good faith that it must disclose such information to prevent imminent physical harm or financial loss.
- Kakona believes in good faith that it must disclose such information to commence an investigation or take action regarding illegal activities or suspected fraud.

- Kakona believes in good faith that it must disclose such information per auditing, compliance, and corporate governance functions.
- Kakona believes in good faith that it must disclose such information to defend Kakona in litigation or a regulatory action.
- Kakona believes in good faith that it must disclose such information, or advised to do so by law, such as in response to a subpoena, or similar legal process, including to law enforcement agencies, regulators, and courts in the United States and other countries where we operate.

Kakona will not sell your Personal Information to third parties unless Kakona is in the process of entering into a merger with another business, acquisition of another business, or the sale of all or a portion of Kakona assets and the information is needed to support the sale or transfer of business assets.

This Privacy Policy only governs when and why Kakona discloses Personal Information.

This Privacy Policy does not apply to the practices of third parties that Kakona does not own or control, or individuals that Kakona does not employ or manage. The use of your Personal Information by third parties that you access through the Site is governed by the privacy policies of such parties and is not subject to Kakona's control. Kakona is not responsible for the privacy or security practices of other websites on the Internet, even those linked to or from Kakona Site. Kakona encourages you to ask questions before you disclose your personal information to others.

Kakona may disclose information about you that is not personally identifiable. For example, Kakona may provide our partners, (such as HubSpot), or other third parties with reports that contain aggregated and statistical data about Kakona users.

Personal Information Retention

To determine the appropriate retention period, Kakona considers the type and volume of the information, the negatives that can result from un-permitted access to such information, why we gather such information and the availability of achieving the goals of such gathering through alternative means.

If you have elected to receive marketing communications from us, we retain information about your marketing preferences for a reasonable period of time from the date you last expressed interest in our content, products, or services, such as when you last opened an email from us. We retain information derived from cookies and other tracking technologies for a reasonable period of time from the date such information was created.

Tracking Technologies - Indirect Data Collection

Kakona implements cookies to store user information and track user activities. User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information. Cookies enable us to monitor your activity across sessions of interaction between your device and the Site. Please see "Choice and Control," for information on how to refuse cookies.

Choice and Control

While Kakona does need to gather certain information to make your Kakona experience personalized and to conduct transactions for you, we want to give you the ability to control how your information is provided and shared.

- **Email Preferences.** For various reasons, Kakona may contact you about our services or your activity.
- **Cookies and Tracking Devices.** Upon visiting Kakona's site for the first time (or after clearing a browser's cache) you will be shown a notification. You may click "accept" to clear the notification. However, we will, by default, use cookies when you visit our site.

The notification states: "This website uses cookies to remember you and improve your experience. To find out more see our Privacy Policy."

If you would like to decline cooking tracking, you can manage how your browser handles cookies and other tracking devices by adjusting the privacy and security settings on your browser. If accessing our Site by a mobile device, you may manage the information your mobile device shares, such as cookies, tracking technologies, and location information, by adjusting your mobile device privacy and security settings.

Security of Personal Information

Kakona strives to use commercially acceptable means to protect your Personal Information, however, no method of transmission over the Internet, or method of electronic storage, is 100% secure and therefore Kakona cannot guarantee absolute security of your personal information. We strive to maintain a system that reasonably safeguards Personal Information and we have put in place appropriate security measures to accomplish the foregoing.

EU Data Subject Rights

In certain circumstances, you have the following rights under data protection laws in relation to your Personal Information:

- Request access to your Personal Information (commonly known as a "data subject access request"). This enables you to receive a copy of the Personal Information Kakona holds about you and to check that Kakona is lawfully processing it.

- Request correction of the Personal Information. This enables Kakona to have any incomplete or inaccurate data held about you corrected, though we may need to verify the accuracy of the new data provided.
- Request erasure of Personal Information. This enables you to ask Kakona to delete or remove Personal Information where there is no good reason for Kakona continuing to process it. You also have the right to ask us to delete or remove your Personal Information where you have successfully exercised your right to object to processing (see below), where we may have processed your information unlawfully or where we are required to erase your personal data to comply with local law. Note, however, that Kakona may not always be able to comply with your request of erasure for specific legal reasons which will be notified to you, if applicable, at the time of your request.
- Object to gathering of your Personal Information where Kakona is relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to gathering on this ground as you feel it impacts your fundamental rights and freedoms. You also have the right to object where Kakona is gathering your Personal Information for direct marketing purposes. In some cases, Kakona may demonstrate that it has compelling legitimate grounds to gather your information which override your rights and freedoms.
- Request restriction of gathering of your Personal Information. This enables you to ask Kakona to suspend the gathering of your personal data in the following scenarios: (a) if you want Kakona to establish the data's accuracy; (b) where The Pointe Bahamas's use of the data is unlawful but you do not want Kakona to erase it; (c) where you need Kakona to hold the data even if Kakona no longer requires it as you need it to establish, exercise or defend legal claims; or (d) you have objected to The Pointe Bahamas's use of your data but Kakona needs to verify whether it has overriding legitimate grounds to use it.
- Request the transfer of your Personal Information to you or to a third party. Kakona will provide to you, or a third party you have chosen, your Personal Information in a structured, commonly used, machine-readable format. Note that this right only applies to automated information which you initially provided consent for Kakona to use or where Kakona used the information to perform a contract with you.
- Withdraw consent at any time where Kakona is relying on consent to gather your Personal Information. However, this will not affect the lawfulness of any gathering carried out before you withdraw your consent. If you withdraw your consent, Kakona may not be able to provide certain products or services to you. Kakona will advise you if this is the case at the time you withdraw your consent.
